Cellnex Finance Company S.A.U. ("**Cellnex Finance**"), a wholly-owned subsidiary of Cellnex, has successfully completed a EUR-denominated bond issuance for an amount of EUR 1,000 million (with expected ratings of BBB- by Fitch Ratings and BB+ by Standard&Poor's) aimed at qualified investors under its Euro Medium Term Note Program (EMTN Program) and guaranteed by Cellnex.

The bond is maturing in April 2026 at a coupon of 2.25% and issued at a price of 98.932% of its nominal value.

The bonds are expected to be listed on the Irish Stock Exchange.

The net proceeds from the issues will be used for general corporate purposes.
